

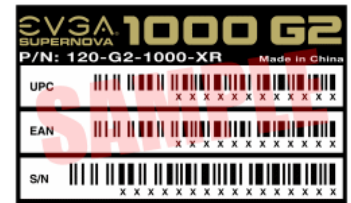

2. Go to evgarebate.com and enter the promotion number **74236**.
3. Fill out and print the registration form for this promotion.
4. Cut out and enclose the ORIGINAL UPC code from the product packaging. An example of a UPC code can be found at the right of these instructions.
5. Enclose a copy of the sales receipt dated between 01/06/2017 and 02/02/2017 indicating your qualifying purchase.
